Also some part of boundary wall is below than 6ft of height. Thus, the school is directed construct the Pacca Boundary wall from all sides with minimum 6 ft height and upload the videography of the same on the school website before making the school operational. 9. The school is required to construct the partition in girls urinals. 10. The school is required to shift Library in bigger room with minimum size of 112 sqm 11. The school is required to appoint special educator and counsellor as per Board norms 12. The school is required to renew all the mandatory certificates time to time
