b) Quarterly statements of the accounts of the Trust shall be submitted to the Board of Trustees.

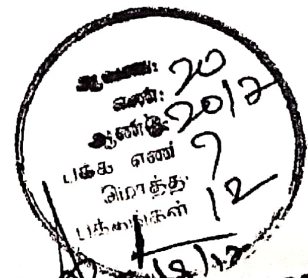
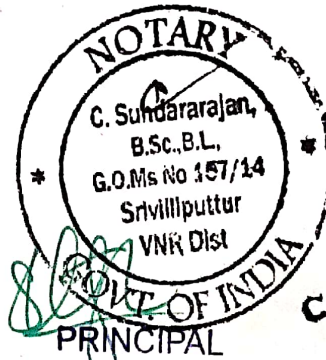
c) The accounting year shall be from 1st April to 31st March and first of such account shall close on 31st March 2018.
